1 child	\$185.00 per month / *Pro-rated \$135.00
2 children	\$280.00 per month / *Pro-rated \$200.00
3 children	\$375.00 per month / *Pro-rated \$270.00
4 children	\$470.00 per month / *Pro-rated \$340.00

BEFORE SCHOOL CARE RATES

1 child	\$5.00 drop in/ \$20 per week
2 children and up	\$8.00 drop in/ \$30 per week

***The months of August, December and March are pro-rated for After School Care.**
