The Parents/Guardians understand and agree that their obligation to pay the full amount of all tuition and fees for each academic year is unconditional once the registration fee for the applicable academic year is paid. There will be no refund of amounts paid or cancellation of amounts payable ***under any circumstances***, including without limitation circumstances of any student's absence, suspension, withdrawal or dismissal from the School, except that if a student's vacated position is filled by a new eligible student, then any tuition and fee payments payable after the date the position is filled will be refunded if already paid or canceled if unpaid. The School will be under no obligation to fill vacated positions. The Parents/Guardians agree to pay tuition and all fees, including late fees, in accordance with the attached Tuition and Fees Payment Schedule, incorporated in this Enrollment Agreement by this reference. **PLEASE REFERENCE PAGE 38 IN OUR FAMILY HANDBOOK TO REVIEW TUITION/INCIDENTAL PAYMENT POLICY. This policy will be enforced for the 2019-2020 School Year.**

## IV. RELEASE AND INDEMNITY.

THE PARENTS/GUARDIANS, FOR THEMSELVES, THE STUDENTS NAMED ABOVE AND THEIR RESPECTIVE HEIRS, REPRESENTATIVES AND ASSIGNS, AGREE TO, AND HEREBY DO, RELEASE AND FOREVER DISCHARGE SANTA CRUZ CATHOLIC SCHOOL, SANTA CRUZ CATHOLIC CHURCH, THE CATHOLIC DIOCESE OF AUSTIN AND ALL OF THEIR RESPECTIVE EMPLOYEES, AGENTS, REPRESENTATIVES, PREDECESSORS, SUCCESSORS AND ASSIGNS ("RELEASED PARTIES"), FROM ANY AND ALL CLAIMS, ACTIONS, DAMAGES, LIABILITIES, COSTS AND EXPENSES ARISING OUT OF OR RELATING TO INJURY OR DAMAGE TO THE PERSONS OR PROPERTY OF THE PARENTS/GUARDIANS OR THE STUDENTS NAMED ABOVE, EXCEPT FOR ANY INJURY OR DAMAGE CAUSED BY THE GROSS NEGLIGENCE OR WILLFUL MISCONDUCT OF ANY OF THE RELEASED PARTIES. THE PARENTS/GUARDIANS AGREE TO INDEMNIFY AND HOLD HARMLESS SANTA CRUZ CATHOLIC SCHOOL AND SANTA CRUZ CATHOLIC CHURCH FROM ANY AND ALL INJURY AND DAMAGE CAUSED BY THE PARENTS/GUARDIANS OR THE STUDENTS NAMED ABOVE.

## V. General.

No delay or omission by any party to exercise any right or power under this Enrollment Agreement will impair any such right or power or be construed to be a waiver thereof. This Enrollment Agreement constitutes the entire agreement between the parties with respect to its subject matter. This Enrollment Agreement may be amended or modified only in a writing signed by the Principal of the School and the undersigned. This Enrollment Agreement will be governed by and construed in accordance with the laws of the State of Texas.
